

## RESOLUTION NO. 2025-15

### A RESOLUTION OF THE COTTONWOOD HEIGHTS PARKS AND RECREATION SERVICE AREA BOARD OF TRUSTEES TO APPROVE THE CANCELLATION OF THE NOVEMBER 4, 2025 ELECTION FOR DISTRICT 2 BOARD OF TRUSTEES and DETERMINING THE UNOPPOSED DECLARED CANDIDATE, PATTI HANSEN, TO BE ELECTED TO THE DISTRICT 2 BOARD OF TRUSTEES

**WHEREAS**, the terms of one (1) Trustee in District #2 are set to expire at the end of 2025, and **WHEREAS**, because of the expiration of terms, an election was called for November 4, 2025, pursuant to applicable sections of the Utah Code, to fill those one (1) Trustee position for District #2, and

**WHEREAS**, notice of the election was duly noticed to the public, and

**WHEREAS**, only one (1) candidate filed declarations of candidacy to run for the one (1) position available in District #2, said candidate being Patti Hansen, and

**WHEREAS**, no other individual gave notice of intent to run as a write-in candidate, pursuant to Utah Code §20A-9-601, and

**WHEREAS**, the Cottonwood Heights Parks and Recreation Service Area Board of Trustees can choose to cancel an election where the number of declared candidates, including declared write-in candidates, do not exceed the number of open Trustee positions subject to election, and may certify the unopposed declared candidates to be elected to the Board of Trustees

**WHEREAS**, The Board of Trustees of the Cottonwood Heights Parks and Recreation Service Area desires to cancel the upcoming General Election for District 2 to be held on November 4, 2025 and determines the unopposed candidate, Patti Hansen, to be elected to the Cottonwood Heights Board of Trustees for District #2;


**NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE BOARD OF TRUSTEES OF THE COTTONWOOD HEIGHTS PARKS AND RECREATION SERVICE AREA AS FOLLOWS:**

1. **Adoption.** The Board of Trustees of the Cottonwood Heights Parks and Recreation Service Area approves the cancellation of the November 4, 2025 election for District 2, due to only 1 candidate on the ballot and determines that the unopposed candidate, Patti Hansen, to be elected to that position.
2. **Severability.** If any section, part or provision of this Resolution is held invalid or unenforceable, such invalidly or unenforceability, shall not affect any other portion of this Resolution, and all sections, parts and provisions shall be severable.

3. Effective Date. This Resolution shall become effective immediately upon its passage
